Mission & Vision

Ayida Agriculture is committed to empowering Haitian farmers with access to tools, resources, and a proven agricultural model that supports long-term independence, profitability, and land stewardship.

We envision a nation where local farming thrives and Haitian land is cultivated with dignity and purpose.

Business Overview

For our pilot phase, Ayida Agriculture will only be accepting applications from farmers who own at least 10 acres of land with direct access to water. Farmers who do not have water access must have a minimum of 18 acres to qualify, but will be placed on a waitlist for future inclusion once irrigation solutions are in place.

Ayida's model is non-extractive—farmers retain ownership of their land and crops. We provide farming equipment, support infrastructure, and technical guidance. Rental costs for equipment are only collected after the farmer has made profit from harvest sales.

How Ayida Works

- Farmers apply and are vetted for land ownership and water access
- Ayida supplies tools, equipment, and startup support
- Farmers grow and sell produce; Ayida collects fees only after sales
- All tools remain Ayida property and are reused for future cycles
- Each farmer builds a sustainable business with zero upfront debt

Startup Budget Summary

The table below outlines the estimated startup costs per farmer and per department.

Investment Terms

We currently welcome two primary investor tiers:

1. ****Silent Partner Tier**** - Starting at \$10,000 with returns ranging from 8–10%. Ideal for supporters who want to help from a distance.
2. ****Philanthropic Tier**** - Supporters who fund operations purely for the mission, without expecting financial return.

General Terms:

- Minimum Investment: \$10,000
- Maximum Equity per Investor: 3%
- All investors are protected by a silent partner clause (unless otherwise negotiated)
- All returns begin after year one of operations
- Profit sharing and social impact reports are distributed quarterly

Projected Revenue & ROI

These revenue projections show what Ayida can achieve as we grow from 20 to 75 active farmers. The estimated investor returns—10% in Year 1, up to 18% by Year 3—are highly competitive compared to traditional investment options.

Impact investors typically seek a blend of financial return and social value, and Ayida offers both. The combination of fair returns, low-risk collection after harvest, and long-term national impact makes Ayida an attractive and meaningful opportunity.
